WHAT IS DUAL LANGUAGE IMMERSION (DI)?

Dual language Immersion is a 50/50 instructional model beginning in 1st grade and lasting in the elementary model until 6th grade. Students spend half their day learning in English and the other half learning in Spanish or Chinese. Through developmentally appropriate curriculum, students naturally pick up the language as they learn other subjects. The program is structured on the total language learning approach incorporating content-based instruction, and explicit language instruction.

WHO SHOULD APPLY?

Any parents currently living within the Weber School District boundaries and whose student is entering the first grade in 2016. There must also be a commitment to having the student participate all 6 years.

HOW TO APPLY?

Submit this application to Weber School District 5320 Adams Ave. Ogden, UT 84405 by March 24, 2016, no later than 3:30pm.

WHAT IS OUR GOAL?

Our goal is that our immersion students will become bi-literate and bilingual. They will be functionally proficient in speaking, reading, and writing in either Chinese or Spanish and have a strong appreciation for cultural diversity.

HOW ARE STUDENTS CHOSEN?

A weighted lottery process is used in selecting students. Weighting includes but not limited to living in boundary of the school, sibling in the DI program (this does not guarantee a position), the target language spoken in the home. This is a program for all students, cognitive strengths and disabilities will not be considered by the school officials.

NOTIFICATION

Placement information will be mailed directly to your home. You will be notified in writing by April 20th as to whether or not your child is selected for placement in the Dual Immersion Program for the 2016-2017 school year. If your child is selected, you must respond on the form mailed to you indicating whether you choose to accept program placement by May 2, 2016. Notification received after May 2nd could affect your child's placement in the dual immersion program. If your child is selected for the program and you do not live in the school boundary, a registration and boundary exception form must also be completed and turned in to the school by May 2, 2016. Acceptance of placement requires a commitment to continue in the program through 6th grade. If you do not plan to stay in the area or are unable or unwilling to provide transportation (as needed) please do not apply.

ADDITIONAL INFORMATION

- If your application is not turned in by March 24, 2016, your application will not be processed.
- Students currently in the program will not re-enroll each year, but will remain in the program.
- Families living outside the attendance area of selected school must provide transportation.
- Families with students enrolled in the program will not be allowed to request a specific teacher since only one English teacher will be available to work with the target language teacher.

- After a three week period, a second conference will be scheduled at a mutually agreeable time within five school days.
- If the problems have not been resolved, the student's place in the program will be reviewed by the District language specialist, teacher, principal, and parents.
- If the child's teacher, principal and district representative recommends transfer, the student will be removed from the program.
