Goal #1:

One-Hundred percent of students K-6 will make growth with the DIBELS testing from the Beginning of the Year (BOY) to the End of the Year (EOY).

Goal #1 Action Steps

In addition to classroom Tier II instruction, 100% of students who are identified as intensive by the DIBELS test will receive additional interventions from the Reading Intervention Team, ELL aide, or Special Education team.

**Exception: Parents will be able to opt-out of this service upon request. In addition to the Reading Coach, multiple aides will be employed to provide small-group reading interventions to at-risk readers.

DIBELS assessments and progress monitoring will be conducted at regular intervals for students in Grades K-6.

Five aides will be used to assist with reading intervention services (\$12,000).

We will purchase additional technology (Interactive Boards) to replace SMART Boards. This will increase student engagement and provide for targeted small-group interventions. (\$35,000)

DIBELS assessments will be conducted three times per year for all students in grades K-6. Additional monitoring will also happen throughout the year.

Goal #2

Goal #2

75% of students will achieve 75% or better on the end-of-year math benchmark assessments K-6.

Goal #2 Action Steps

PLC collaboration and common assessments will focus on identified essential learning objectives.

PLC Professional Development training will be provided to teachers to focus upon the PLC process, identifying essential learning targets, instructional strategies, and common formative and summative assessments.

Substitute teachers will be used to assist in this process.

A least three common formative and/or summative assessments will be given in math in each grade during the school year.

Students who are identified to be below benchmark on the common assessments will receive focus, concept-specific interventions in the classroom. Common assessments and fluency data will be used to modify instruction and interventions.

Technology aides will also be providing valuable services, along with counseling and library services to help facilitate grade-level planning and collaboration on a consistent basis.

Behavior Aide services will be used to enhance character ed to improve essential academic skills, including attendance (\$17,000).

Math instruction will be supported with instructional technology (i.e. projector purchases, voice enhancement systems, IPADS, Chromebooks, and SMART technology repair/replace new/lease.

Chromebook carts will be partially funded to facilitate engagement and opportunities for students to practice math skills (ALEKS (\$3,100), Imagine Math, Zearn, RISE Benchmarks) (\$25,000). This will support the 1-1 purchase of technology.
