#### Goal #1:

One hundred percent of students K-6 will make progress on the composite measure of Acadience testing from the beginning of the year (BOY) to the end of the year (EOY).

### Goal #1 Action Steps

In addition to classroom Tier II instruction, 100% of students who are identified as intensive by the Acadience Reading test will receive additional interventions from the Reading Intervention Team, ELL aide, or Special Education team.

Note: Parents will be able to opt-out of this service upon request. In addition to the Reading Coach, multiple aides will be employed to provide small-group reading interventions to at-risk readers.

Acadience assessments and progress monitoring will be conducted at regular intervals for students in Grades K-6.

Six aides will be used to assist with reading intervention services.

Additional technology (interactive boards) to replace SMART boards. This will increase student engagement and provide targeted small-group interventions (\$40,000)

One-to-One device will be provided (leased) for each student K-6. (\$25,000)

Mental Health specialist will be in the school 2-days/week (\$5,000.00)

Behavior Aide to assist with student behavior and learning (\$27,000)

Additional Aide Salary for RTI/small group. (\$15,000).

Research-based math software licenses will be purchased to assist students to improve math strategies and essential learning targets. (20,000).

Subs to cover classes while teachers administer the Acadience Math (1000).
